No. AO/24/APPT/2020(11)-DE(S)Pt-I: Applications are invited from the intending and eligible candidates for appointment of 1140 (One Thousand One Hundred Forty) **Pre-Primary Teachers** on contract basis in the Department of Education(S), Manipur under Samagra Shiksha Mission.

For PWD and Meritorious Sports Persons, reservation of seats shall be as per the existing Rules.

3. Eligibility:

**Essential Qualifications**

- (i) Class XII or its equivalent from a recognised board with at least 50% Marks or
- (ii) Class XII or its equivalent from a recognised board with at least 45% marks in accordance with the National Council for Teacher Education Regulation, 2002 notified on 13.11.2002.

provided that those selected as Pre-Primary Teacher in this recruitment should mandatorily complete the ***Diploma in Nursery Teacher Education/Pre-School Education/Early Childhood Education Programme (D.E.C.Ed.) of duration of not less than 2 (two) years or B.Ed (Nursery) from NCTE recognised institution*** within 5 years from the date of joining the service.

4. The upper age limit for the candidates shall be 38 years as on date of notification. Age limit shall be relaxed by 3 years for OBC Candidates and 5 years for ST/SC Candidates. For PWD/Meritorious Sports Persons (Candidates), additional relaxation as permissible by rules shall apply.

5. The appointment shall be purely on Contract basis for the period from the date of contract agreement up to the last date of that financial year as per regulation prescribed by the Government and extendable from time to time with the approval of the Government.

6. They shall be paid monthly honorarium of Rs. 15,000/- per month for 11 months in a year as per scheme norms. The payment of monthly remuneration/wages shall be drawn under Muster Roll Form 21. The rate of honorarium may vary depending upon the PAB approval.

7. The mode of selection for engagement of Pre-Primary Teachers of Schools on contract shall be on the basis of **written test** only.

8. Scheme of Examination:

The examination question paper will consist of 100 multiple choice Questions (MCQ) carrying equal weightage as given below:



No.AO/24/APPT/2020(11)-DE(S)Pt-I: In continuation and partial modification of this Office Notification of even No. dated 8<sup>th</sup> January, 2024 and in pursuance of Government approval conveyed Vide Letter No.SM3-301/8/2024-EDN(S)-EDN(S) dated 9<sup>th</sup> March, 2024 pertaining to engagement of 1140 (One thousand One Hundred Forty) posts of Pre-Primary Teacher on Contract Basis in the Department of Education(S), Manipur under Samagra Shiksha, it is to inform to all the concerned that eligible and willing candidates, who are sponsored by the concerned Employment Exchange, may apply for the post online with relevant documents and Examination Fees latest by **26<sup>th</sup> April, 2024 (Friday)** by following the link provided in the official website of the Department **[www.manipureducation.gov.in](http://www.manipureducation.gov.in)** or directly going to the **URL [www.pptmanieduregistration.com](http://www.pptmanieduregistration.com)**.

2. Preference will be given to those candidates who have completed the Diploma in Nursery Teacher Education/Pre-School Education/Early Childhood Education Programme (D.E.C.Ed) of duration not less than 2 (two) years or B.Ed (Nursery) from NCTE recognised institution only and have fulfilled all other eligibility conditions.

In case, there are not enough such candidates, then those candidates who are eligible except the educational qualification of Diploma in Nursery Teacher Education/Pre-School Education/Early Childhood Education Programme (D.E.C.Ed) of duration not less than 2 (two) years or B.Ed (Nursery) from NCTE recognised institution may be considered for engagement with the condition that they should complete Diploma in Nursery Teacher Education/Pre-School Education/Early Childhood Education Programme (D.E.C.Ed) of duration not less than 2 (two) years or B.Ed (Nursery) from NCTE recognised institution before the 5<sup>th</sup> re-engagement if extended.

3. They shall be engaged with monthly honorarium of Rs. 15,000/- per month for 11 months extendable from time to time as per requirement of the Government and co-terminus with the Scheme.

4. The Examination Fees for this recruitment shall be Rs. 500/- for General and OBC Candidates and Rs. 300/- for SC/ST candidates. Application fees for PWD candidates will be exempted. However, supporting certificates should be attached. Further, the mode of Payment of Examination Fee shall be remitted through online payment (Debit Card/ Credit Card/ net banking/ UPI) only at the time of online Form fill-up.
