(iii) With three years' service in the grade rendered after appointment thereto on a regular basis in the Pay Band-2, Rs. 9300-34800 with Grade Pay of 4600 revised to Level-7 (Rs. 44900-142400) of the Pay Matrix of 7<sup>th</sup> Pay Commission or equivalent in the parent cadre or department; and

(b) Possessing the following educational qualifications and experience:

(i) Bachelors' Degree in Veterinary Science from a recognized university or institute; and

(ii) Post Graduate Degree in any branch of Veterinary Science and Animal Husbandry with specialization in animal nutrition from a recognized university or institute.

Two years' experience in the Animal Nutrition and quality control of feed.

**Note 1:** Period of deputation (ISTC) including period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (ISTC) shall not be exceeding fifty six years as on the closing date of receipt of application.

**Note 2:** For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January 2006 or the date from which the revised pay structure based on the sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

2. The period of deputation and other terms and conditions shall be governed by Department of Personnel and Training's Office Memorandum No. 6/8/2009-Estt.(Pay II) dated 17.06.2010 and the guidelines of DoP&T issued on the subject from time to time.

3.
