This online application process is the only valid method. No other application modes will be accepted.

Online registration on the portal will close on 11-03-2025 at 23:59 hrs. Candidates are advised to regularly check the website for any updates regarding the selection process. Candidates are advised to keep the essential documents ready by the time of start of online registration. CoPA shall not be responsible for any omission on part of the candidates to keep themselves informed of the updates provided through the website.

While applying for the post, the applicant should ensure that he/she fulfills the eligibility and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and /or that he/she has furnished any incorrect/false information or has suppressed any material fact(s), his/her candidature will stand rejected. Candidates shortlisted shall be required to produce / Upload requisite document in OAP, if shortlisted. Candidates applying for the reserved quota shall be required to produce / upload in OAP, the latest validated caste certificate, EWS certificate etc., if shortlisted.
