## **SELECTION PROCESS**

All applications received will be screened with respect to the prescribed job specifications and candidates fulfilling the eligibility conditions shall be called for Personal Interview.

In case of receipt of more no. of eligible applications, shortlisting of Candidates for interview will be in the ratio of 1:10 in order of merit to the number of vacancies in each category. The merit list will be drawn on the basis of total percentage secured in relevant Diploma in Engineering.
